Scope of Work – Additional items added

Along with the AHU replacements and improved control of the makeup air for the Medical School Building, we are also providing replacements and upgrades of the exhaust system components and controls. Included in this scope is the replacement of butterfly dampers with opposed blade dampers, the replacement of pneumatic actuators with DDC actuators, addition of UPS systems to serve the exhaust controls to ensure constant operation during a power outage, and changes of the system's sequence of operation based on a wind study performed by CPP.
