Students enrolled in two separate academic programs during the same award year are referred to as *Dual Degree*. The Office of Student Financial Services has identified you as a dual degree student for the current academic year.

Per institutional policy, financial aid eligible students enrolled in dual degree, MD/MPH or MD/PhD programs may only receive aid for **one program per term**. Dual degree, MD/MPH and MD/PhD students have an annual or aggregate maximum amount of aid that may be awarded from any financial aid program. If you are receiving or plan to receive financial aid at more than one institution or program within the same term of enrollment, please notify each institution. If the total amount of aid the student receives exceeds the applicable annual or aggregate loan limit or if there is any duplication of non-institutional costs, the student is responsible for resolving the over award and may lose financial aid eligibility until the issue has been resolved.

Note: Dual degree, MD/MPH and MD/PhD programs are not applicable to consortium agreements as dual degree programs confer separate program degrees and are not contractual agreements between two institutions.
