Important information about Emergency Loans:

- Emergency loan applications require the approval of the Emergency Loan Committee (ELC). The ELC will review emergency loan applications within 24 to 48 hours, except for tuition emergency loans which will be reviewed at the end of business on the day the application is submitted.
- Applications for an emergency loan submitted after **12 p.m.** will be processed the following business day with the following exception: Applications submitted three days before the end of the month will be processed when the new month begins.
- · Decisions will be made on a case-by-case basis on applications submitted in the following circumstances:
 - · When financial aid is expected to disburse to your tuition account within 30 days of the emergency loan request
 - · When a refund was processed on your tuition account within 30-45 days of the emergency loan request
 - When the emergency loan is applied for 30 days or less before the term ends
 - When graduation is within 30 days of emergency loan request
- Approved emergency loans will be directly deposited into your bank account. For students not enrolled in direct deposit, a paper check will be mailed to the current address on file.
- Emergency loan applications and associated documents should be uploaded to myUTH as "Emergency Loan Application". Applications should not be sent via email.

EMERGENCY LOAN ACKNOWLEDGEMENT

By applying for an emergency loan, you are entering into a legally binding agreement between yourself and The University of Texas Health Science Center. Therefore, it is imperative that certain conditions for the loan are understood.

Please read the following:

 <u>www.uasconnect.com</u>. Financial aid disbursements <u>will not</u> be applied toward any outstanding emergency loan balance.
- I understand that this loan must be repaid by the due date on your MPN or within 90 days, whichever occurs first.
- I understand if the emergency loan is not paid in full by the due date, there will be a \$15.00 late charge assessed and a HOLD will be placed on my records which will prevent financial aid disbursements and may affect class registration.
- I understand that the entire amount, plus any penalty charges, may be referred to a collection agency.
